#### Meeting called to order at 5:00pm

Civic Organizing Purpose: To broaden governing responsibility to include those impacted, but not replacing existing governing responsibilities of board members and supervisors.

It was requested by member of COLA board to add topic on funding for spraying and Commissioner McNally requested to have added a topic regarding the County and AIS funding/budget.

Motion by Hams, seconded by Weingart to approve the agenda with additions. Motion passed.

Motion by Kutil, seconded by Hams to approve the outcomes. Motion passed.

• \*Treasurer's Report –

Any invoices from Lake Associations?
No invoices needing approval were brought forward to the meeting.

• 2021 AIS Year End Reports

Votruba let the COLA group know that December 31 the County AIS reports were submitted to the DNR. These reports detail how AIS funds were spent in the County. Votruba thanked the Lake Associations for sending him their completed metrics sheets.

• 2022 AIS Budget

Commissioner McNally let the group know at a recent County Board meeting the County Board approved increasing the AIS Administration percentage from 15% to 20%. He also mentioned that keeping the boat inspector work separate from Administration should keep the Soil and Water from overspending in the Administration category.

• 2022 Boat Inspectors – reallocation of funds to potentially hire third inspector

Due to the COLA board decision to not put money towards a decontamination unit this year the COLA and likely not purchase a unit, the COLA board was asked if they would be interested in moving funds so that a third boat inspector could be hired. Funds saved for the decontamination unit could be moved to hire an additional inspector. Looking at the data Kyle Hams with Knife Lake didn't think an additional boat inspector will be required. Upon looking at the data he noted it was mostly minor things such as leaving plug in the boat or not removing all the weeds off boat. Overall, the COLA board thought that the two inspectors covered the accesses well.

• 2022 Soil and Water Newsletter - AIS Article

For this topic, Votruba asked the COLA group if they had any ideas for topics for the AIS article in the Soil and Water Annual Newsletter. Anne Leroy mentioned that we could have an article in newsletter explaining the differences between native aquatic plants and invasive aquatic plants and the importance of having native plants in the lake. It was also recommended that having in the newsletter something recommending ice fishermen to clean up their garbage on the ice would be good to include as well.

• Set Policy for Lake Association Carry Over

In response to Pomroy Lake and Ann Lake having large amounts of unspent AIS funds, the COLA board was asked if they would be open to setting policy on how much carry over is allowed each year. A possible limit would be \$5000, an exception could be made for lakes that had plans on how they would be spending the funds. Jeff Hamme with Ann mentioned Ann Lake would have no problems setting policy on carry over. However, before anything is approved the COLA board would like Pomroy's input on the topic.

• Funding for AIS Spraying

Kyle Hams mentioned that Knife Lake can never fully fund their AIS spraying. Typically, every year they apply for DNR grants for spraying to help fund the treatments. It was mentioned in past years that Lake Associations have donated funds to other Lake Associations to assist in their treatments.

Lewis: Oren Larson mentioned that Lewis will be treating for Curly Leaf Pondweed next year and will be

applying for a DNR grant for spraying

Fish: Jim Kutil mentioned that they will be sponsoring a carp fishing tournament this summer. Fish Lake

Association is currently looking into a carp removal program. Jim said he would be talking to carp

fishermen.

Quamba: Nothing new to report.

### **Other Items:**

- Open Public Comment Period no public comment provided
  - 1. Anne Leroy mentioned she would like to know the legality for the Townships to support AIS treatments. COLA board will look into statutes for Townships to support AIS spraying. It was thought during meeting that the Townships should not be supporting AIS treatments.
  - 2. McNally also commented that AIS funds should be used at all public accesses in the County to prevent spread of AIS, this should include Lake Five and Eleven. The COLA board however did let him know that Lake Five and Lake Eleven did have boat inspectors during the 2021 inspection year. Only the river accesses and lakes with no public accesses had no boat inspectors.
