- 2. NRCS Report –Planning for 2023 Environmental Quality Incentives Program (EQIP) and Conservation Stewardship Program (CSP). 2-EQIP applications have been received in Isanti and 2-CSP. Cover crop certification is taking place to ensure they've been planted to the required specifications. Went to windbreaks and shelter belts training, held in Piliger. 5. Project Updates, in consent agenda – any questions.

5.1. State Cost Share spending this year

Discussed contract #2022.02 – shoreland restoration project contracted for \$14,508.70. Total estimated cost is \$19,400. Bids came in higher than what was estimated by TSA. TSA's analysis of the bids does not warrant an increase in the offered funding. With these large costs the landowners may not want to do this project this year or at all.

There was a proposal to use \$3,000 of our State Cost Share funding towards a cover crop incentive payment already contracted through the SRWMB. This would avoid sending back our total State Cost Share funds that expire at the end of this year.

Motion by Sanford second by Johnson to approve \$3,000 of our State Cost Share funds to go towards the cover crop project, contract #2022.04 with the SRWMB. Granting Pomije authority to sign this new contract as able.

The City of Mora is looking into planting a pollinator garden in downtown Mora, located between City Hall and Kev's Depot. Yet to be finalized, possible funding through our Lawns to Legumes grant.

Paulsen shared information on cost estimates and other details she's learned on our proposed purchase of a notill drill for rent to promote no-till planting of cover crops and inter-seeding for pastures/hay land. Proposing a working length of 12', costs are up 30%. Depending on size of drill and brand, \$36,000+. Spring is a busy time for drill rentals consuming up a ½ time person.

The board asked for an estimate on the cost benefit financial analysis of purchasing a drill for rent.

Discussed the need to set-up a site to share data and calendars between staff, along with the difficulties of choosing an option that would work with the one NRCS networked computer we have. This will also be a need as we start communicating and sharing data between our partners for the Snake Watershed Plan implementation efforts. A quote for a Google sharing site is \$12/mo./user.
