<u>Civic Organizing Purpose</u>: To broaden governing responsibility to include those impacted, but not replacing existing governing responsibilities of board members and supervisors.

Motion by Kutil, seconded by Weingart to approve the agenda with additions. Motion passed.

3. *Approve outcomes, January 13, 2022 - corrections and additions?

<u>Motion</u> by Kutil, seconded by Jahnke to approve the outcomes from our Jan. 13, 2022, meeting. Motion passed.

4. *Treasurer's Report

Any invoices from Lake Associations? None brought forward. Expenses for boat inspectors, 2 umbrellas \$47.22

<u>Motion</u> by Kutil, seconded by Jahnke to accept the treasurers report and approve the boat inspector umbrella expenses for \$47.22. Motion passed.

5. *Proposal for setting maximum carry over amounts (~\$5,000) from year to year unless Lake Association has long term plan for spending. – Discuss

The proposal for setting a maximum carry over of \$5,000 for any lake assn. AIS balance to carry forward from year to year. If passed, options were presented to recalculate the budget totals incorporating this new amount or setting aside a Left-Over Fund for the board to decide how to spend.

<u>Motion</u> by Kutil, seconded by Jahnke for setting a maximum carry over of \$5,000 for any lake assn. AIS balance to carry forward from year to year and for the new funds be placed in a Left-Over Fund for the AIS/SWCD board to decide how to spend. Motion passed.

6. *2022 Boat Inspectors – update on hiring 2 inspectors

SWCD Board 1/18 approved \$14.50 & 15/ hr. rates (returning inspectors) – need \$550 to support this

Pomije reviewed that at the Jan. SWCD Board it was approved to hire the boat inspectors at the \$14.50 & 15/ hr. rates (returning inspectors). Do fund this an added \$550 is calculated to be needed. There are a few options on where from the budget to pull these needed funds: the contingency fund, the decontamination unit fund or the education funds.

<u>Motion</u> by Kutil, seconded by Jahnke for approving to pull the needed \$550 for the boat inspector 2022 salaries from the education fund. Motion passed.

7. *2022 AIS Budget (Open Discussion)

Motion by Kutil, seconded by Jahnke to approve the 2022 AIS budget as presented with the above changes as discussed and approved. for setting a maximum carry over of \$5,000 for any lake assn. AIS balance to carry forward from year to year and for the new funds be placed in a Carry-Over Fund for the AIS/SWCD board to decide how to spend. Motion passed.

8. AIS Coverage on lakes without Lake Assn. (Lake 5 & 11)

<u>Motion</u> by Kutil, seconded by Jahnke to approve the outreach to Lakes 5 and 11 to engage them their interest in joining and/or using the AIS funds on their lakes. Motion passed. McNally provided Pomije with a couple of names from these lakes to start contacting (e.g., potato lake).

9. Decontamination Unit – next steps

This item was tabled until a discussion for the May AIS-COLA meeting. Pomije will plan to bring information on the CD-3 units for this discussion. Another option are the simple tool units used at some WI lake access sites.

Lake Assn. Check-Ins / Discussion:

- ✓ Each Lake Assn. open to discuss concerns they have & report on activities
 - o Jim Kutil from Fish Lake said they are planning to survey and spray for curly leaf pond weed in May. Also looking into a carp survey (Sept-Oct) with an estimated cost of \$3,000 and \$5,000 for carp removal. The market is 10 cents / lb. carp currently.
 - Oren Larson from Lewis said they are planning to spray curly leaf on 4.6 acres this year from their weed delineation from 2021.
