Pomije provided a quick update on our Snake planning efforts. I'm scheduled to present our plan to the BWSR committee on 1/5. She invited everyone to attend (remote or in-person) to support our plan for approval. She mentioned the Nov. SRWMB voted and passed to seek administration of the plan's implementation under the SRWMB if the counties wish this. On 12/6 I presented to the Kanabec Board a powerpoint explaining the complexities and options of the plan's implementation organizational structure with a recommendation to consider this further. They voted and passed to seek administration of the plan's implementation under the SRWMB. This is all assuming that the SRWMB would remain a commissioner voting only entity. Given this decision our next steps were discussed. We also discussed if we would also wish for 2 votes within any implementation board as the Kanabec Board may be seeking 2 votes for themselves. No preferences on this were expressed by the board. The Steering committee continues to make progress on our work plan, given staff available time.
