Some of the members volunteered activities they did in 2022 to be included with the year-end reports. Deanna explained the options available for submitting the information to her by 12/18. For 2023 Ray mentioned seeking out training for ambassador volunteers to help with AIS education and to offer free t-shirts and hats to those finishing the training.

Lake Assn. Check-Ins / Discussion:

✓ Each Lake Assn. open to discuss concerns they have & report on activities

<u>Lewis</u>: Oren mentioned in 2022 they had plats in the water by the dock to monitor for any new invasive mussels, etc. They are planning to apply for a DNR grant for curly leaf control funding.

They had a well-attended picnic in August. He shared their total phosphorus (25 ppm) and chlorophyll-a (10 ppm) testing with the group. These are mid-range results for our east central area. They sprayed 4.6 acres in 2022 and are planning for a new vegetation survey in preparation for their 2023 spraying efforts.

<u>Knife</u>: The Johnson's mentioned that they have a lake assn. meeting next week where they will be reviewing the prep. work to sending out landowner letters to set up the lake vegetation spraying for 2023. Letters are going out in Jan. and due back in March. They spray about 50 acres.

<u>Ann</u>: Ray said they had good results with their spraying this year. They are awaiting the results from the sediment core sampling from 2022. He said their secchi disc reading have gone down with the lower water levels, more sediment.

<u>Fish</u>: Marv said their wine tasting fundraiser was very well attended. They have a fishing contest coming up in Feb. Also looking to promote carp removal through a tournament and raise funds for their control efforts. They've sprayed 26 acres. Deanna mentioned meeting with Dave, others from Fish and EutroPHIX Company on their water quality concerns and sediment core sampling.

Lake Full of Fish may be interested in forming a Lake Assn.

Kanabec County - Coalition of Lake Assn. (COLA) - Aquatic Invasive Species (AIS)

Purpose Statement: Meet regularly utilizing civic standards to organize ourselves, building capacity and infrastructure as needed to support our goals in leading toward better water quality through a focus on Aquatic Invasive Species.

Civic Standards:

1. All those impacted by the problem are stakeholders. Together they define the problem, set goals and work toward solutions as active citizens.

- 3. All stakeholders are engaged in making decisions and policies that contribute to the common good.
