8.2. Snake Watershed Partnership Update.

The completed access project under contract #SRWMB.2022.1 was approved, including \$1,751.06 in KSWCD project development staff time. In addition to Pine Co., now Aitkin Co. has submitted a resolution for dissolution of the SRWMB. As a requirement for the proposed dissolution, a public hearing was set for the 23<sup>rd</sup> of October.

The first Snake Partnership meeting was held 10/23. Seven of the big 8 Snake Partners have signed on to the JPA, with the exception of ML County. During this meeting Kurt Beckstrom was elected chair with Belkholm as vice-chair. A draft of the by-laws was reviewed, bringing up many questions for the group. Questions for example how often do they plant to meet, who signs the project contracts and a need for seeing how projects flow through the Steering Committee and over to the Partnership Board meetings for approval. The next 10/11 Steering Committee meeting will start drafting options to address these questions. No new date/time has been set for the Partnership Board Meeting.

9.1. \*AIS funding for controlling carp. Fish Lake is looking to evaluate Carp control using AIS funding.

A discussion was had looking at the materials provided. Different species of carp are listed by the DNR as both Prohibited species and Regulated species. AIS funds have been used for control of prohibited species such as curly-leaf pondweed. Common carp is in the less controlled, regulated species list.
