- **6.** NRCS Report (Brian Steffen)
 - The Conservation Stewardship Program (CSP) has zero classic assessment and ranking and zero renewals for FY24
 - CSP- Grassland Conservation Initiative (GCI) is no longer a program
 - EQIP-25 applications received in Kanabec County. 5 decided to defer until next year, 19 moving forward this year and 1-SU2. More funding is anticipated to arrive this summer.
 - Resource Conservation Partnership Project (RCPP) has 2 applications that moved to approve.
 - Steve Cole to attend our meeting in Feb. to discuss our cooperative service agreement

The Annual NRCS Civil Rights Review - the agreement was reviewed and signed by all members. Steffen responded to a clarifying question from Belkholm.

7. Business Section

7.1. <u>Snake Watershed Partnership Update</u>. The SRWMB denied funding 2 minor proposals. One for a map to be developed summarizing all our priority maps into one and another outreach proposal using rain barrels. These were not funded due to the SRWMB seeking dissolution.

Seeking approval on three Snake Watershed Partnership service contracts with us:

- 1. Master contract for services
- 2. Statement of Work (SOW) for outreach services for \$83,666
- 3. SOW for shoreland protection projects (<\$20,000 threshold) totaling \$5,000, one project ready to contract on Fish Lake, will be seeking a contract amendment with the landowner

In discussion on our Watershed Program Coordinator position: With our last posting of this position; the applicants were not at the level of experience we were seeking. The position description was revised to increase the minimum level of experience sought. The revision now also includes all watershed activities into this one position, instead of 1/3 of the activities under the

District Manager position. To seek input on the description from Paul S. with Pine SWCD prior to finalizing. The board was recommending a new review of the description against the county pay scale and then to report the position until it's filled.
