Actual Results

2023: From this last buffer inventory from early 2023, four questionable non-compliance landowners have been contacted via letters, requesting them to contact us. One of these landowners has been into our office multiple times. They have been uncooperative and this case will be forwarded to BWSR to continue their compliance efforts. Follow up is still needed with three of these landowners. One only needs verification on the area being planted. In 2023 the SWCD was lacking a Technician for 5 months due to staff turn-over, thus the reason for continued buffer work needed.
